4. **CDSN PROJECT COORDINATOR REPORT (Lynn)** Bob talked to Lynn, she will be making webpage updates after receiving CDPHE's data call – which should happen soon.

5. **UPDATES**

- Webpage updates, where Lynn is in the process. Bob discussed the ArcGIS changes, thought to involve vectors. Jordan volunteered to check into the changes since Metro has looked at these changes. Discussion on the merits of having the webpage QAQC'd by a third party.
- Meeting to be schedule with Colorado Monitoring Framework. Anticipate a meeting in February, after CMF Board has time to discuss vacancy's prior to our next meeting.

- Data Literacy in Trinidad – Date moved out to Feb. 22, 2019. Tyler and Tammi are working on a presentation. Bob shall attend and will be available to answer any CDSN questions from the group.

6. **NEW BUSINESS**

- Tim Steele is requesting some support from CWQMC for the attendance of fee cost for the NWQMC Conference. He will be attending the conference for one day and giving a presentation which includes how they used CDSN data information (metals in Clear Creek). Tim also has offered to market the CDSN Data
